Fostering Agricultural Value Chains in Eastern South Asia

CUTS International in collaboration with *Rashtriya Grameen Vikas Nidhi* (RGVN, Guwahati), SNV (Bhutan) and Unnayan Shamannay (Dhaka) organised a Sub-Regional Policy Dialogue on 'Fostering Agricultural Value Chains in Eastern South Asia' at Guwahati, Assam on June 25, 2016. This event was organised under the Sustainable Development Investment Portfolio (SDIP) supported by the Department of Foreign Affairs and Trade (DFAT), Government of Australia.

The objectives of the workshop were to discuss the possibilities and hurdles associated with the trading of agriculture products within and across borders; and seek solutions to address those hurdles.

It brought together government agencies, regulators, private institutions and private players engaged in the agriculture sector to understand and deliberate on how to best harness agriculture value chains and its potential in the sub-region comprising of the North Eastern states of India and its neighbours in the Brahmaputra basin.

Stakeholders from various industry associations, business chambers, civil society, export promotion councils, think tanks and universities, among others gathered to reflect upon the findings, share their concerns and recommendations.
