Rajasthan State Level Inception Workshop under the GRANITE Phase-2 Project

Jaipur, India, September 05, 2007

The Rajasthan State Level Inception Workshop under the GRANITE Project Phase-2 project will be organised on September 05, 2007 inviting a multistakeholder participation from the farmer unions, weaver unions, agriculture institutes like National Institute of Agricultural Marketing (NIAM) Jaipur, Institute of Rural Management (IRMA), Anand and Institute for Integrated Learning in Management (IILM) Jaipur, banking and micro finance institutions like National Bank for Agriculture and Rural Development (NABARD) and other community based organisations (CBOs).

The training workshop familiarised the participants with various livelihood models which are used to address the livelihood concerns of poor. Numerous studies indicate that services have the potential to provide a significant development outcome to the Doha Round of negotiations. Unfortunately, progress in this area is directly linked to breakthroughs in Agriculture and Non-Agricultural Market Access (NAMA) negotiations. Before the suspension of the Round in July 2006, around 30 revised offers were made. There were not much for the LDCs in those offers as modes and sectors of interest to the LDCs were not included.
