Sustainable Development in South Asia *Exploring Trans-boundary Cooperation in Agriculture, Water and Energy*

CUTS International, along with its partners in Bangladesh, Bhutan, India, Nepal and Pakistan, implemented the Sustainable Development Investment Portfolio (SDIP) project, which is a regional programme in South Asia supported by the Department of Foreign Affairs and Trade, Government of Australia. A regional dialogue workshop was organised at New Delhi on July 29, 2016.

This workshop aimed to disseminate key advocacy messages on issues related to food, water and energy security in South Asia and discuss opportunities and challenges of regional/sub-regional cooperation for sustainable agricultural practices, agricultural value chains, water resource management, and scope for intra-regional trade and investment opportunities in the energy sector in South Asia.

Trade Policy

A Tool to Facilitate the Participation of SMEs in Global Trade

CUTS International organised a session on 'Trade Policy: A Tool to Facilitate the Participation of SMEs in Global Trade?' at the World Trade Organisation (WTO) Public Forum at Geneva on September 27, 2016. It was moderated by Pradeep S. Mehta, Secretary General, CUTS International. While opening the session, he observed that presentations and discussions would aim at brainstorming around the question "Why trade policy is an important tool to facilitate the participation of SMEs in global trade."

With some examples from South Asia and Sub-Saharan Africa, the different presentations made a case for the necessity and the kind of changes required in the trade policy of low-income countries for facilitating this objective, particularly from the point of view of:

- employment generation in tradable manufacturing and services
- helping small and medium enterprises (SMEs) to become a part of global value chains
- facilitating SMEs to be a driver of innovation driven future economy including linking it to the Hangzhou G20 Summit Declaration

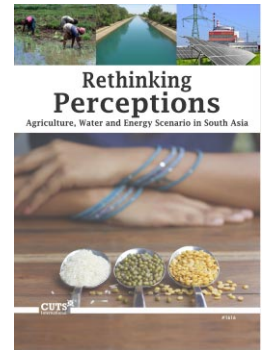
Rethinking Perceptions

Agriculture, Water, Energy Scenario in South Asia

The study points out the need for regional value chains in agriculture, resolution of upper and lower riparian conflict issues in trans-boundary water sharing and adoption of renewable energy models in South Asia. It is based on a combination of household survey, key informant interviews and stakeholder discussions of close to 1000 respondents across the Indus, Ganges and Brahmaputra river basins. It includes field insights from 24 locations in 11 sample sites across the countries, viz. Bangladesh, Bhutan, India, Nepal and Pakistan.

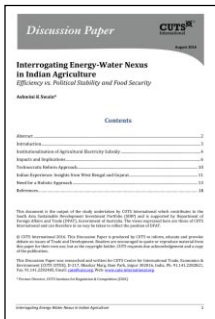

Efficiency vs. Political Stability and Food Security



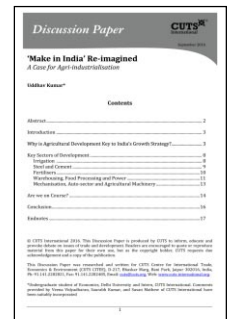
Agricultural electricity subsidy is a unique feature of the Indian electricity supply industry. This paper argues that agricultural electricity subsidy in India is closely linked with food security, poverty alleviation, state finance, water scarcity and now increasingly with climate change. Drawing on state level experience, the paper suggests a holistic approach to reform electricity subsidy and water use inefficiency in agriculture.

A Case for Agri-industrialisation

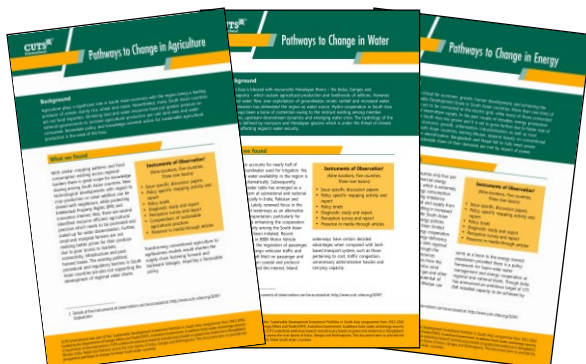
