## **Bangladesh, Bhutan, India, Nepal** Connectivity and Trade Facilitation

CUTS International along with Asian Development Bank organised a side event during 'Aid for Trade Global Review 2019' at Geneva on July 04, 2019. Bipul Chatterjee moderated the session on 'Bangladesh, Bhutan, India, Nepal (BBIN): Connectivity and Trade Facilitation'. This session deliberated on good policies and practices for sustained trade by addressing related to women empowerment, youth, livelihood development, resilient infrastructure, digital connectivity and skill development.

CUTS International organised a Roundtable Discussion on Connectivity and Trade Facilitation in the Bay of Bengal Region: *Role of the BBIN Motor Vehicles Agreement* at New Delhi on August 13, 2019.

The main objective of this event was to deliberate on key findings of the survey and stakeholder consultations conducted in eight BBIN corridors and chalk out an action agenda to further boost connectivity and trade facilitation in the BBIN sub-region.

CUTS International organised a Regional Policy Dialogue on Connectivity and Trade Facilitation in BBIN sub-region of the Indo-Pacific at Dhaka, Bangladesh on September 04, 2019. More than 40 participants comprising government officials, policy experts, civil society representatives and media personnel participated in the deliberation. The event also underlined that digital connectivity including the use of new technologies, such as blockchains should be effectively used to develop an online trade facilitation platform and appropriate risk management system to facilitate faster cargo clearance at border crossings.

#### **Promoting Women Traders in North-East India**

This event was organised as part of the project 'Women Traders in the Borders of North-East India' funded by the Australian High Commission, at New Delhi on August 28, 2019. The objective of the

project was to understand opportunities, prospects and capacity needs of women entrepreneurs as well as aspiring traders in five states of the North-East (Meghalaya, Assam, Manipur, Arunachal Pradesh, and Nagaland).

The purpose of the event was to bring government officials, civil society, women entrepreneurs in business chambers and other relevant stakeholders from the North-East states to deliberate further on the outcomes of National Dissemination Meeting organised at New Delhi on May 29, 2019. The deliberations focussed on developing an action agenda for the promotion of women traders in the North East.



#### Promoting Trade and Tourism in Transboundary Waterways of Meghna Basin

This report captures the findings of a project titled "Inclusive cross-border trade in Meghna basin in South Asia" that was initiated under Transboundary Rivers of South Asia (TROSA) programme as part of a series of short-term research to co-produce knowledge and evidence on different issues which will inform the programme's evidence-based influencing and advocacy work in the region. The study primarily focussed on Kushiyara, Gumti and Haora rivers of India for the prospects of cross-border trade with Bangladesh as well as Umngot river and upstream of Gumti for exploring tourism potential. The study explored on how the riverine communities can benefit from inclusive inland water transport and

This report is a milestone in this trajectory as it looks at the prospects of inland water transport as an ecosystem service and how its sustainable management can realise economic growth and improve livelihoods.

Inland navigation in these rivers would not only improve hinterland connectivity of this isolated landscape but would also integrate it with mainland India through the Bangladesh-India Inland Waterways Protocol Routes.
