Potential Trade between India and Pakistan

1. Introduction

- 1.1 This note is prepared with an objective to underline the trade potential between India and Pakistan, which can be, in another sense, considered as an opportunity cost of not leveraging their geographical proximity. Because of lack of infrastructural and institutional connectivity, without a holistic bilateral trade framework and due to the prevalence of negative, restricted and sensitive lists on both sides of the border, there are little efforts to realise their potential trade, which is estimated to be as high as approximately US\$507 billion when one considers currently traded products.
- 1.2 It is also important to point out that some of this potential trade is happening through informal routes such as places like Dubai, Hong Kong, Singapore. This note argues that if measures are taken towards realising this trade potential then not only producers and consumers of both countries will gain but also there will be substantial reduction in informal trade leading to significant revenue generation for both the governments.
- 1.3 This can happen if Pakistan fulfills their import requirements of those products by sourcing them from India and vice-versa by India. It can not only result in trade creation for both the countries but also and more importantly will help them in developing their production base, akin to Make in India.
- 1.4 In this respect, Pakistan is in a more advantageous position as currently traded products are covering 18.44 per cent of its potential trade of US\$466 billion. In case of India, it is 12.44 per cent of its potential trade of US\$41 billion. In other words, of the total potential trade in terms of currently traded products, almost 92 per cent of this potential trade will accrue to Pakistan. Other than producers and traders of both countries, consumers will benefit as we can safely assume that the unit values of these products in India and Pakistan are less than in those countries from where they are largely being sourced at present.
- 1.5 In this note, the potential of currently traded products is calculated by applying International Trade Centre's methodology of subtracting the exports of country Y to country X from the import capacity of receiving country X in similar product lines. Latest data of the year 2013 have been used. We have taken into account those products on which India has substantial export to the world but comparatively less export to Pakistan (as compared to Pakistan's import of those products from the world). Similar exercise is done for Pakistani products. In order to derive the percentage value of exports of either country, the following formula has been used:

[(Potential Value of Trade of Country X to Country Y) divided by {(Export of Country X to the World) minus (Export of Country X to Country Y)}] multiplied by 100

1.6 Furthermore, apart from calculating this potential trade based on currently traded products, this note has identified potential products which are currently not traded between the two countries. They are identified as per inputs obtained from Pakistan Business Council, Karachi Chamber of Commerce and Industry, Rajasthan Chambers of Commerce and Industry, Marwar Chambers of Commerce and Industry, and local (Jaipur) chapters of Federation of Indian Chambers of Commerce and Industry and Confederation of Indian Industry.

2. Major Results

- As compared to 2011, in 2013, there was 29.62 per cent increase in the value of India's export to Pakistan in currently traded products. It was mainly due to Pakistan's decision to replace its positive list of 1946 items with a negative list of 1209 items in 2012. In case of Pakistan, it was 47.59 per cent increase. This can be credited to the establishment of an Integrated Check Post at the Attari-Wagah border.
- While analysing yearly time series fluctuations in Pakistan's total import from the world in similar products lines, as compared to 2011, in 2013, there was a decline of 0.45 per cent. Thus, Pakistan external trade is becoming more stable, which is positive development for India while exploring more trade in currently traded products. In case of India, there was declining trend of 0.0078 per cent, showing that India's external trade is although becoming more stable but that happening at a rate slower than that of Pakistan.

3. Conclusions and Way Forward

- 3.1 It is tautological to say that India and Pakistan are yet to realise their untapped trade potential. For doing so, both countries need to resume and sustain their dialogues on economic cooperation. In this regard, state/provincial governments and business chambers have to take lead to advocate with the respective central/federal government. Not only new production and trading opportunities will be generated but also there will be new revenue generation including at the sub-national level.
- 3.2 Infrastructural as well as institutional connectivity are to be improved. Other than improving connectivity for financial transactions, customs cooperation and exploring mutual recognition of standards through existing but ineffective agreements, cross-border trade through new land routes (and including connecting them through rail routes) must be opened. There exists several historical land routes bordering both sides of Punjab, Gujarat, Rajasthan and Sind which, if made functional, will facilitate trade towards this potential and will also spur local economic development in bordering states/provinces.
- 3.3 The only land trade route through the Attari-Wagah border, even with a restriction of allowing trade in only 137 items on the part of Pakistan, is a success story. It is because of coordination among various agencies for facilitating trade including taking into account security concerns. By taking into account security and other functional aspects of trade, this success story is to be replicated by establishing Integrated Check Posts at various border points such as at Munabao-Khokrapar bordering Rajasthan and Sind.
- 3.4 The opening up of identified but yet to be operational land trade routes would help Pakistan to stabilise its economy. Such trade will help India to implement its Make in India initiative more effectively and will create jobs and production networks not only between India and Pakistan but among other countries of South Asia. This is a win-win situation and Pakistan can even negotiate the granting of its Most-Favoured-Nation status to India in lieu of mutually preferential access to each other's market.
