


#### India-Bangladesh Agriculture Trade

Demystifying Non-Tariff Barriers to India-Bangladesh Trade in Agricultural Products and their Linkages with Food Security and Livelihood

This Report attempts to identify existing non-tariff barriers (NTBs) that are restricting agriculture trade between India and Bangladesh and provides feasible recommendations to address them. It focussed on seven land ports in West Bengal and Tripura, and examined 15 agricultural commodities that are traded through these ports. It highlighted some key NTBs that must be addressed and proposes recommendations on short, medium and long term basis to improve the volume of bilateral trade.

# Trade and Transport Connectivity in the Bay of Bengal Region

The Report aims to assess the impact of cross-border trade, transit and their related protocols on local economic parameters, particularly relating to the livelihoods of direct stakeholders of such cross-border trade and transit with the sub-region. The study is largely based on data and evidence collected through primary work in Bangladesh, Bhutan, India, Myanmar and Nepal, and presents analysis of the views taken from differentiated group of stakeholders involved in and having deep interest on issues of Trade, Transport and Transit Facilitation within these countries.




#### **Bordering on Happiness**

### An Assessment of Socio-Economic Impacts of Bangladesh-India Border Haats

CUTS, together with Unnayan Shamannay, our partner in Bangladesh, and with the support of the World Bank, has undertaken a study of border haats in order to understand and examine their effects on poverty alleviation through income and employment generation and other multiplier effects including the formalisation of informal trade. The study also seeks to comprehend the gender implications of border haats. A comprehensive questionnaire survey was done, covering approximately 400 respondents to gather data and information on the economic, social and political impact of haats.

# Promoting Trade and Tourism in Transboundary Waterways of Meghna Basin

The study has been successful in creating evidence of cross-border trade using mechanised boats along the short trans-boundary stretches in Barak, Gumti and Haora rivers of the Meghna basin. It has highlighted the prospects of community-based tourism in supplementing the income of tribal communities in Chabimura (Tripura) and Dawki (Meghalaya). The findings of this study clearly indicate the prospects of cross-border navigation from Sonamura to Daudkandi and linking it to the Protocol Route 3 (Kolkata-Karimganj) in the Meghna basin by providing transshipment facilities at Daudkandi. Also, the current mode of bank-to-bank trade in

Karimganj-Zakiganj can be extended up to Ashuganj, Bangladesh once the navigability is improved in this stretch.


# Role of Multi-modal Connectivity in Fostering Value Chains in the BBIN Sub-region

The paper aims to underline how multi-modal connectivity can facilitate and strengthen the existing Regional Value Chains (RVCs) with respect to specific commodities, and/or enable the creation of new RVCs in this sub-region. Our study concludes that except for the Kolkata-Dhaka corridor, which experiences time and resultant cost barriers primarily due to traffic congestion at the Petrapole-Benapole border, multi-modal connectivity is a cost-efficient mode for moving goods among the BBIN countries through various other existing corridors.

### Trade Facilitation in the BBIN Sub-region Challenges and Opportunities in Implementing the BBIN MVA

Trade facilitation has emerged as one of most important issues in the regional integration agenda of Bangladesh Bhutan, India, Nepal (BBIN) sub-region of South Asia. Cross-border trade through land routes encounters challenges in respect to soft and hard infrastructure. In order to address these challenges, the BBIN countries signed a Motor Vehicles Agreement (MVA) to facilitate seamless movements of cargo and passenger vehicles. This paper analyses the challenges in the implementation of the BBIN MVA and TFA commitments of the BBIN countries and put forward recommendations to address them.

#### Reviving Riverine Livelihoods through Short Haul Trade and Tourism

This Policy Brief presents the challenges and recommendations with respect to cross-border trade via waterways and river tourism in Barak, Gumti, Haora, and Umngot rivers in the Meghna basin. While highlighting the prospects of cross-border trade in Barak and Gumti rivers, it rules out the cross-border navigation in Haora river and identifies community-based tourism (CBT) as a supplementary source of income for riverine communities on the bank of Gumti river in Chabimura (Tripura), Umngot-Piang rivers in Dawki (Meghalaya, India) and Jaflong (Sylhet, Bangladesh). Promoting cross-border trade through waterways would require

infrastructural facilities, necessary regulations, need based dredging operations at shallow locations to maintain navigability and market linkages.

The BBIN MVA is a step towards sub-regional economic cooperation. A field survey of CUTS International and Unnayan Shamannay in Bangladesh has studied key transport corridors and identified hurdles that are limiting the flow of goods in and out of Bangladesh. ### Landlocked Bhutan Identifies Infrastructural Obstacles to Improved Regional Connectivity

Road connectivity and infrastructure is the backbone of all the needed development in a landlocked country. Bhutan, being a landlocked nation, needs to develop its infrastructure urgently because the present state of infrastructure in Bhutan is at sub-optimal level. This infrastructural development will be helpful for Bhutan in ideally utilising its economic potential. Further, this development will impact the livelihood of the local economy, women and ultimately resulting in reduction of poverty. Therefore, this Policy Brief brings out issues related to hard infrastructure in Bhutan affecting connectivity, and offers suggestions to overcome them.

## Plugging Infrastructural Lacunae in Nepal for Aiding Regional Connectivity

Tariff and NTBs are not the only impediments to poor integration and inter country trade within the BBIN sub-region, there are infrastructure-related impediments too. Poor quality of infrastructure has emerged as a key deterrent to trade and smooth implementation of the BBIN MVA. This Policy Brief presents some of the key findings of the field survey conducted across three identified road corridors under the BBIN initiative in Nepal, which indicate that efficient



infrastructure will be a key driver for the smooth flow of goods in and among the BBIN nations. Though emphasis is laid on improving the hard infrastructure (road network, bridges, railways, ports) the impact of soft infrastructure (ICT) on trade must also be recognised.
