CUTS @ WTO Public Forum 2006

The World Trade Organisation (WTO) organised its annual Public Forum on September 25-26, 2006 in Geneva. CUTS Centre for International Trade, Economics & Environment (CUTS CITEE) organised two sessions in this Forum on September 26, 2006.

Operationalising Aid for Trade

The objective of this session was to deliberate the issues for operationalising Aid for Trade (AfT) from the perspectives of developing countries, particularly least developed countries (LDCs), and other stakeholders so as to evolve a roadmap for taking forward this initiative. Keeping in mind the recommendations of the Task Force on AfT, this session discussed the following issues: (1) Expectations, particularly of LDCs, from the AfT initiative (2) Role of donors and inter-governmental organisations for operationalising AfT (3) An effective AfT partnership: Local accountability and global review.



Ambassador Mia Horn

The speakers for this session were: Mia Horn Af Rantzien, Ambassador and Permanent Representative of Sweden to the UN and Other International Organizations in Geneva; Susan Barton, DFID, UK; Khadija Rachida Masri, Ambassador and Permanent Observer of the African Union in Geneva; Harmon Thomas, UNCTAD; Martina Garcia, OECD.

Some key recommendations were: involvement of stakeholders; donors' expertise on trade issues; role of the WTO in the implementation of AfT. Mainstreaming trade into the developmental strategies is another key issue, which require utmost attention. The session identified the donors' role in AfT operationalisation. There is a need for donors to become partners in development. In order to realise this objective, the donors should support the country led process of development.

It is crucial to make an assessment of the current inequality situation and the likely impacts of increased trade on inequality. For this identification of the barriers that prevent the poorest, engaging women and marginalised groups in trade opportunities is must.

The operationalisation of AfT should not be linked to the Doha Round negotiations. Another important question that will need to be addressed by Africa is whether it should push for binding commitments or not under the initiative. If not, why and with what *quid pro quos*? G-20 Civil Society Views on WTO

This session was jointly organised by FES and CUTS. The objectives of the working session were to highlight the G-20 civil society perspectives on the WTO and to identify the main challenges for G-20 civil society.

The speakers for this session were Thomas Manz, Coordinator of the Dialogue on Globalisation Programme, Friedrich-Ebert-Foundation (FES), Berlin, Germany; Umberto Celli Jr., International Trade Law and Development Institute, Brazil; Mzukisi Qobo, Research Associate, South African Institute of International Affairs (SAIIA), South Africa; Pradeep S. Metha, Secretary General, CUTS International, India; Ricardo Melendez-Ortiz, Chief Executive, International Centre for Trade and Sustainable Development (ICTSD), Switzerland.

The presentations of the panellists and the discussion showed the following points:

- G-20 civil society is not homogenous, but rather a very heterogeneous and highly complex entity, comprising of a wide range of perspectives.
- in order to be effective at global level, G-20 civil society groups have to start at national level to lobby their interests.
- it was mentioned that G-20 civil society has the responsibility to guarantee that the benefits of trade liberalisation are distributed equally among the people.

One principal recommendation is that the WTO should provide for a more structured and institutionalised procedure to include civil society actors in the discussion of global issues. As a precondition for a more civil society engagement, it was mentioned that the WTO procedures should become more transparent and inclusive. - to find ways as to how the four partner organisations in India could complement each other in delivery and meeting SDC objectives of capacity building of GMS countries.

OECD Global Forum on Trade

Bipul Chatterjee participated in OECD Global Forum on Trade, which was held in Mexico City on 23-24 October. The theme was "A Trade Policy Dialogue on the Multiple Dimensions of Market Access and Development". He made a presentation on "Relative Importance of North-South and South-South Trade".

FES/WTO Asia Regional Dialogue

Ritu Lodha participated in a conference jointly organised by FES/WTO Asia Regional Dialogue on 'WTO at Cross-Roads? – Experiences and Expectations around the Doha Agenda' in Singapore on October 30-31, 2006. The objectives of the conference include:
