COENCOSA Phase II - Final Meeting

CUTS with support from The Asia Foundation organised the final meeting of COENCOSA Phase-II in New Delhi on April 11, 2013.

Considering the need for institutionalising an effective system of public-private-people dialogues to address non-tariff barriers (NTBs) affecting regional trade in South Asia, the objective was to endorse a business plan which has been formulated to advocate for an interventionist and participatory role of the private sector, civil society and other relevant stakeholders in identification and removal/harmonisation of NTBs and to launch a network of policy champions to take forward the agenda.



Participatory Approaches to South Asian Regional Integration and Connectivity

CUTS in partnership with Australian Agency for International Development (AusAID) organised a stakeholder consultation on Participatory Approaches to South Asian Regional Integration and Connectivity in New Delhi on April 12, 2013.

Realising that an inclusive and participatory approach is necessary to achieve progress on development issues in South Asia, the meeting has two objectives:

1. To gain civil society inputs on AusAID's strategy supporting South Asian regional integration and connectivity; and
2. To develop a shared understanding of the big issues affecting progress towards regional economic integration and identify priority actions.



Promoting Participatory Approaches for Removing Regional Trade Barriers in South Asia



CUTS International with support from The Asia Foundation and Federation of Indian Export Organisations, organised a half-day consultation meeting on Promoting Participatory Approaches for Removing Regional Trade Barriers in South Asia in Kolkata, West Bengal on May 24, 2013.

The objective of the meeting was to present the issues relating to NTBs in South Asia as well as to present proposals for enhancing the process of NTB reforms in the region through a participatory approach and to elicit the views and concerns of multiple set of stakeholders, particularly those of the private sector, on the said proposals.

Addressing Barriers to Rice Seeds Trade between India and Bangladesh

CUTS International with support from Bill and Melinda Gates Foundation organised the launch meeting of a project entitled 'Addressing Barriers to Rice Seeds Trade between India and Bangladesh' in Kolkata, West Bengal on April 19, 2013.

The main objective of the meeting was to ensure that members of the project team, Project Advisory Committee and other experts including key participants/informants and project partners are on to the same footing/page as far as project activities, outputs and outcomes are concerned. Additionally, it is also for validation of activities, outputs and outcomes; and discussion on activities, outputs and desired/expected outcomes.



Environmental Standards and their Trade Impact on Indian Textiles & Clothing Sector

CUTS International with support from the Ministry of Foreign Affairs, through Royal Norwegian Embassy, Delhi, organised a dissemination meeting of the project entitled, 'A Study of Environmental Standards and its Trade Impacts on Indian Textile and Clothing Sector' (SESTI) in Oslo, Norway on June 14, 2013.

In the meeting, key findings from the study were presented. Three presentations were made: a) Barriers to the Success of Eco-Labels for Textiles & Clothing: A Stakeholder Approach by Eivind Sto, Director SIFO; b) Indian Stakeholder Perspectives Towards Sustainable Textile Standards by Archana Jatkar; and c) Consumer Perspective on Eco-Labeling of Textiles & Clothing: Results from 5 European Countries by Marthe Austgulen, SIFO.

The study was well taken by the participants and discussions pointed out to a great level of attention being paid to T&C sector. A cross section of stakeholders – about 20 participants – from the Ministry of Consumer Welfare, Ministry of Environment, Eco-label Norway, Verner Group and other relevant organisations attended the meeting.



Deadlock on global trade deal needs to be resolved

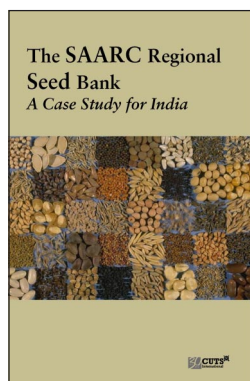
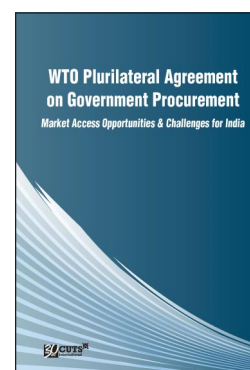

WTO Plurilateral Agreement on Government Procurement *Market Access Opportunities & Challenges for India*

The study undertakes an assessment of opportunities and challenges which India is expected to encounter if it decides to negotiate to accede to the GPA. It presents factors which could inform decision makers and sectoral stakeholders while making the crucial decision on when accession should be undertaken, if at all, and the manner in which welfare objectives can be imbued in the negotiations. Further, an anatomisation of the commitments concluded by member-countries to the GPA presents insights on nuances in negotiating GPA commitments which can add value to an acceding country.

The SAARC Regional Seed Bank: A Case Study for India

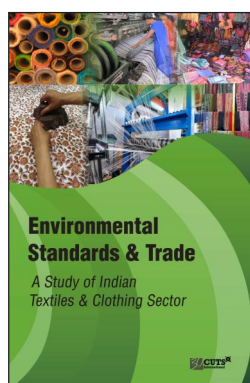
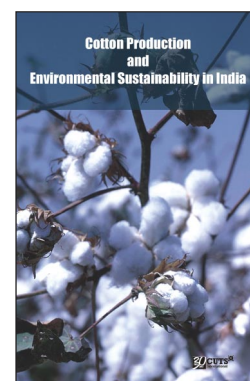

Environmental Standards & Trade *A Study of Indian Textiles & Clothing Sector*

The study was restricted to T&C sector as it plays a very significant role in India in terms of foreign exchange earnings and employment. Moreover, with the dismantling of quotas in 2004 under mandate from the Agreement in Textiles & Clothing of the WTO, the focus has now clearly shifted to the future of the Indian T&C exports. This study generates a better understanding of how standards and quality attributes related to environmental concerns in the T&C sector are defined, developed and managed both in the Northern and Southern hemisphere.

Unlocking the Doha Impasse *Imperative of a Balanced Bali Package*

This Briefing Paper presents a brief analysis of the current state of affairs of the Doha Development Round. While the Doha Round is 'deadlocked' and, inter alia, exogenous circumstances have contributed to the current impasse, there is still a possibility that the WTO members will be able to reach an agreement on specific issues at the next Ministerial Conference in Bali in December 2013. The Paper discusses three possible areas of convergence that could be taken up in the run up to and at the Bali meeting.
