## Events

### Facilitating Connectivity in the Bay of Bengal Region

CUTS in partnership with the East-West Center (EWC) is implementing a project entitled, 'Emerging Markets Summit to Promote Trade Connectivity', which is being supported by the US State Department. The project aims to strengthen the connections between the US and South and Southeast Asian countries in the Indo-Pacific region to enhance trade and other forms of connectivity between South and Southeast Asian countries, particularly between BBIN and BIMSTEC, while including other critical players such as Australia, Japan, and South Korea in the discourse.



A conference was held in Dhaka, Bangladesh on April 11, 2017 which reflected on issues pertinent to connectivity in the Bay of Bengal region with particular emphasis on physical, energy and investment connectivity. It brought together policymakers, experts, private sector, academia, think-tanks and media representatives from the region to discuss key issues and come up with a forward-looking roadmap for overall connectivity in the Bay of Bengal region.

### Creating an Enabling and Inclusive Policy and Political Economy Discourse for Trade, Transport and Transit Facilitation

CUTS organised a Partners' Workshop under the project in Dhaka, Bangladesh on May 18-19, 2017. The event discussed connectivity issues in the BBIN region with focus on facilitating the implementation of the Bangladesh, Bhutan, India, Nepal Motor Vehicles Agreement (BBIN MVA). It also looked to fine tune strategies and approaches for the project aimed at facilitation implementation of the BBIN MVA with inputs from experts and stakeholders.



### Expanding Tradable Benefits of Trans-Boundary Water

CUTS organised a National Policy Dialogue in New Delhi on May 23, 2017. The policy dialogue was part of the project entitled 'Expanding tradable benefits of trans-boundary water: Promoting navigational usage of inland waterways in Ganga and Brahmaputra basins' being implemented in Bangladesh, Bhutan, India and Nepal.

The objective of the dialogue was to share the key findings of diagnostic study on national institutions and governance of inland waterways, knowledge sharing within and across borders on waterways governance, as also the trans-boundary aspects of waterways governance and promote alternative policy discourses for enabling reform measures on better governance of inland waterways in India.

Sub-national policy dialogues were also organised in West Bengal on April 17, 2017 in Assam on April 21, 2017 in Uttar Pradesh on April 27, 2017 and in Bihar on April 28, 2017; respectively.

### Linkages and Impacts of Cross-Border Informal Trade in Agricultural Inputs in Eastern South Asia

CUTS in association with South Asia Watch on Trade, Economics & Environment (SAWTEE) organised a Stakeholder Consultation meeting on 'Linkages and Impacts of Cross-Border Informal Trade in Agricultural Inputs in Eastern South Asia' in Kathmandu on May 02, 2017.

This study has been conducted to assess informal cross-border trade in agricultural inputs across specific locations along India-Bangladesh and India-Nepal border in partnership between CUTS from India, Bangladesh-based Unnayan Shamannay and Nepal's SAWTEE. The project aims to assess the extent of informal cross-border trade in agricultural inputs across specific locations along the India-Bangladesh and the India-Nepal border and figure out the drivers of such informal trade.



### Consumer Gains from Trade: A Case Study on Promoting Trade between Bangladesh and India (Tripura State in North Eastern Region of India) in Specific Agricultural Commodities

India and Bangladesh have natural and cultural complementarities in terms of producing and exchanging goods for everyday consumption. However, in addition to infrastructure bottlenecks, non-tariff barriers negatively affect trans-boundary trade and exchange.

Therefore, this study aimed to facilitate trade in specific agricultural commodities between Bangladesh and Tripura, India through knowledge generation on legal and regulatory framework for cross-border trade in such commodities, identification of solutions to promote market access and evidence-based advocacy to ultimately lead to trade and hence consumer gains.
