Unleashing Connectivity for Inclusive Growth

CUTS International, Himalayan Consensus Institute (HCI), Institute of Chinese Studies (ICS), and The Asia Foundation (TAF) organised a panel discussion entitled 'Unleashing Connectivity for Inclusive Growth – Leveraging Himalayan Consensus' in New Delhi on January 23, 2018.



The discussion introduced the idea behind Himalayan Consensus process to the larger audience in Delhi and developed an initial framework on how this platform can be used to usher connectivity and people-to-people contact. In a moderated session, speakers reflected on the work of their institutions and shaped up the discourse especially in context of how this can shape the larger Act East discourse for India, together with China's Belt and Road Initiative, in the interests of furthering connectivity.

Creating an Enabling and Inclusive Policy and Political Economy Discourse for Trade, Transport and Transit Facilitation

CUTS International organised a National Policy Dialogue on 'Creating an Enabling and Inclusive Policy and Political Economy Discourse for Trade, Transport and Transit Facilitation in and among Bangladesh, Bhutan, India, Nepal and Myanmar' in New Delhi on February 27, 2018.

This dialogue aimed to facilitate trade and transit among the five countries (BBIN+M) by enabling the implementation of the BBIN Motor Vehicles Agreement (MVA) and such other enabling connectivity initiatives through evidence-based advocacy, facilitative dialogues, and capacity building.

It was a platform to share and discuss research findings and recommendations at the national level with policymakers, subject experts, academicians, private sector players, think tanks and media so as to validate and fine tune them.



Reviving Trade through Waterways *Navigating Livelihood Benefits in Ganga and Brahmaputra*

The findings presented in this report have been compiled from country-specific diagnostic studies. It provides an overview of the institutional framework governing waterways, opportunities and challenges with respect to inland navigation in Bangladesh, Bhutan, India and Nepal (BBIN) countries as well as the stakeholder perceptions regarding environmental, livelihood and gender implications of developmental initiatives being undertaken in inland water transport sector.

It has come up with recommendations like developing an integrated strategy for closer cooperation within BBIN countries on cross-border navigational use of Inland Waterways (IWs), engaging local river dependent communities in river training, disaster management, freight handling and other services to supplement their livelihoods and developing ports with multimodal connectivity for seamless transportation.
