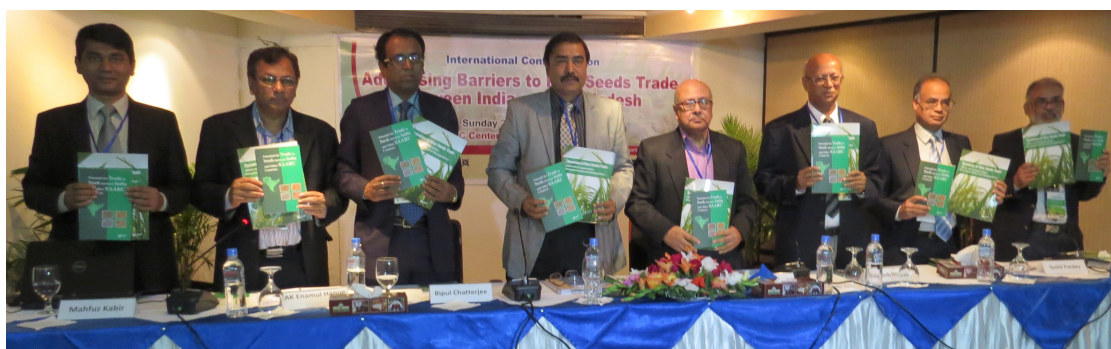

## Stakeholder Consultation Meeting on Public Procurement Policy

CUTS International, is implementing a project on 'National Public Procurement Policy of India' with the support of the British High Commission. As part of this project, two stakeholder consultation meetings were held at Jaipur and Bhopal on December 10 & 20, 2013, respectively.



The objective of these meetings was to understand stakeholders' experience in public procurement system and obtain their-inputs on (draft) policy briefs exploring interfaces between procurement policy and other macroeconomic policies, such as manufacturing, competition, sustainable procurement, trade, fiscal and state-government-level-procurement policy in order to adapt them for the National Public Procurement Policy.
