# Regional Meeting on Multimodal Connectivity in the BBIN Subregion

Cuts International organised Regional Meeting on Multimodal Connectivity in the BBIN Subregion at New Delhi on March 02, 2023, under a project 'Enabling a Political Economy Discourse for Multimodal Connectivity in the BBIN Subregion'. The project is supported by the Foreign, Commonwealth and Development Office (FCDO), UK under its Asia Regional Trade and Connectivity Programme, and was attended by more than 70 participants representing a diverse group of stakeholders.



"Transport connectivity should be the main building block for intra-regional trade and cooperation in the BBIN subregion and this must cover different modes of transportation. Under our work on multimodal connectivity in BBIN subregion, we have not looked at road connectivity in silos, but gone much beyond that. We have identified that several multimodal connectivity options are already present in this subregion and they need to be nurtured to realise their potential to double intra-regional trade in this subregion from the current level of US\$20bn," said Bipul Chattopadhyay, Executive Director, CUTS International.

"Various outputs prepared under the project such as country-specific policy recommendations are vital to achieving inclusive growth in the BBIN subregion," stated Sutapa Choudhury, Deputy Head, Indo-Pacific Regional Department, India and Indian Ocean Directorate, FCDO, UK.

According to Mikiko Tanaka, Head of Subregional Office for South and South West Asia, United Nations Economic and Social Commission for Asia and the Pacific, "There is a need to work on facilitating the conversation flow between different organisations, keeping in mind their multi-layered characteristics at the sub-national, both national and regional level."

# Role of Uttar Pradesh in Shaping India's Logistics Performance

The paper also identifies bottlenecks to logistics efficiency and explores the scope and opportunities that could emerge from the improved logistics performance of the state.

# **Understanding Logistics Ecosystem in Bihar and its Scope for Improvement**

Two major initiatives taken by the Government of India to improve the logistics ecosystem in India are the National Logistic Policy launched in September 2022 and PM Gati Shakti Master Plan launched in October 2021. These two initiatives are expected to reshape India's logistics landscape and lower logistics costs from its current 14 per cent GDP to less than 10 per cent in the coming years. States in India, including Bihar, have a crucial role in this.

This Briefing Paper examines Bihar's connectivity and logistics scenario regarding the availability of transport infrastructure and ease of movement of freight and people. The paper also identifies bottlenecks to logistics efficiency and explores the scope and opportunities that could emerge from the improved logistics performance of the State.

### Role of Northeast Indian States in Shaping India's Logistics Performance

Recognising the salience of logistics, the Union Government has notified the National Logistics Policy, 2022. It is implementing the PM Gati Shakti Master Plan to bring efficiency in logistic services and human resources and integrate infrastructure and network planning. India's States and Union Territories have a pivotal role in logistical planning and development.

This Briefing Paper tries to chart the logistical and connectivity situation in the Northeastern States of India. It attempts to identify the potential of the Northeastern States in terms of trade (both domestic and international), bottlenecks towards improving the state's logistic landscapes, initiatives to improve the logistic ecosystem, and discusses the scope and opportunities to improve its logistic performances.

## Scope and Potential for Multimodal ICPs in the Northeast Region of India

One major development that has significantly contributed to increased trade among the BBIN countries is the establishment of Integrated Check Posts (ICPs) at several border check posts, replacing the Land Customs Stations (LCS).

This Briefing Paper attempts to explore the possibility of connecting operational ICPs in the Northeast Region (NER) of India with multimodal transportation—railways, waterways, and airways. It identifies two ICPs at Sutarkandi in Assam and Sabroom in Tripura, which has the potential to be connected with other modes of transportation in addition to roadways.

Further, the paper also argues for making Dhubri river port in Assam a multimodal ICP based on its strategic location and its proximity to different modes of transportation.


